## CONTRACT DETAILS

1. Services Subject to the terms and conditions of this agreement, Web Sprite Inc. agrees to provide search engine optimization services for the following website: [www.website.com](http://www.website.com). This service includes but is not limited to on-page optimization, link building campaigns, article copywriting, content optimization, social bookmarking, etc.

2. Payment and Terms Client (John Smith) will make total payment of \$4,199 + GST to Web Sprite Inc. for the period starting April 1, 2009 and ending March 31, 2010.

Payment Schedule:

**Setup fee:** John Smith will make a payment in the amount of \$599 + GST to Web Sprite Inc. before April 1, 2009.

**Monthly fee:** John Smith will make a payment in the amount of \$300 + GST to Web Sprite Inc. on a monthly basis for the term of this contract (ie. 12 total monthly payments) with the first one due on April 1, 2009.

Upon client's approval, payments can be processed via the credit card on file exactly on the days noted above. If this charge fails to be processed, the client is obligated to contact Web Sprite and make a payment within 15 days.

3.
